THE PRESIDENCY of the International Criminal Court notes that on 17 March 2015, Judge Geoffrey Henderson filed a request before the Presidency pursuant to article 41(1) of the Rome Statute of the International Criminal Court (“Statute”) and rule 33(1) of the Rules of Procedure and Evidence (“Rules”), wherein Judge Henderson requested to be excused from his function as a judge of Trial Chamber VI in the case of *The Prosecutor v. Bosco Ntaganda*.

On 18 March 2015, the Presidency granted Judge Henderson’s request for excusal from Trial Chamber VI (Annex I).

The Presidency recalls article 39(2)(b)(ii) of the Statute, rule 38 of the Rules and regulation 15(1) of the Regulations of the Court.

The Presidency hereby decides to recompose Trial Chamber VI as follows effective 18 March 2015:
