NOTING Trial Chamber VI’s (the “Chamber”) Decision on victims’ participation in trial proceedings notified on 6 February 2015 (the “Participation Decision”);¹

NOTING article 68 (1) and (3) of the Rome Statute, rules 89(1) and 91(1) of the Rules of Procedure and Evidence and regulations 23 *bis* and 86(8) of the Regulations of the Court;

CONSIDERING that the annexes to the present document are notified with the status “Confidential *Ex Parte*, available only to the Registry” in accordance with the instructions provided by the Chamber at paragraph 24(i) of the Participation Decision;

CONSIDERING that the Chamber in paragraph 24(i) of the Participation Decision ordered the Registry to transmit all complete applications in its possession, without redactions, to the Chamber, on a rolling basis;

CONSIDERING that the Chamber in paragraph 24(ii) of the Participation Decision ordered the Registry to assess the applications into three groups² on the basis of guidance provided by the Chamber in Section III(B) of the Participation Decision;

CONSIDERING that on 2 April 2015, the Registry transmitted 39 simplified application forms it has assessed as falling under Group C, with the necessary redactions applied, to the parties;
