CONSIDERING that in the Decision, the Chamber “*orders the Registrar to transmit the Decision and the record of the proceedings of the Chamber to the Presidency*”⁴;

CONSIDERING that on 11 September at 17:46, CMS received an additional filing to be registered in the case of the Prosecutor vs. Laurent Gbagbo (the “Additional Filing”);
