Judge Silvia Fernández de Gurmendi, Single Judge for Pre-Trial Chamber I (the “Chamber”) of the International Criminal Court (the “Court”), responsible for carrying out the functions of the Chamber in relation to the situation in the Republic of Côte d’Ivoire and the cases emanating therefrom,¹ hereby issues the decision on the “Prosecution Request for Extension of Page Limit” (the “Request”).²

1. On 12 June 2014, the Chamber, by majority, issued its decision confirming the charges against Laurent Gbagbo.³

2. On 16 June 2014, the Chamber, upon request of the Defence, extended the time limit to file any request for leave to appeal the Confirmation Decision until five days following notification of the official French translation of the Confirmation Decision.⁴ On 18 July 2014, the official French translation of the Confirmation Decision and the appended dissenting opinion was notified.⁵

3. On 18 July 2014, the Single Judge, upon request of the Defence, extended the page limit for any request for leave to appeal the Confirmation Decision to 50 pages, including footnotes.⁶

4. On 21 July 2014, the Prosecutor filed the Request, requesting the Single Judge to authorise the filing of a response to any application for leave to

appeal the Confirmation Decision not exceeding 40 pages in length,⁷ arguing that this extension is modest in light of the significant extension granted to the Defence and that the same factors which militate in favour of granting an extension to the Defence justify an extension for the Prosecutor's response.⁸

5. On 29 July 2014, the Defence filed a request for leave to appeal the Confirmation Decision.⁹

6. The Single Judge notes article 82(1)(d) of the Rome Statute, rule 155(1) of the Rules of Procedure of Evidence and regulations 37 and 65 of the Regulations of the Court (the "Regulations").

7. The Single Judge notes that the Defence Request comprises 44 pages including footnotes.¹⁰ Given the length of the Defence Request and the number and nature of arguments to which the Prosecutor will have to respond, the Single Judge is of the view that there exist exceptional circumstances within the meaning of regulation 37(2) of the Regulations. Therefore, the extension of page limit as requested by the Prosecutor can be granted.

FOR THESE REASONS, THE SINGLE JUDGE

GRANTS the Prosecutor up to 40 pages including footnotes for her response to the Defence request for leave to appeal the Confirmation Decision.
