1. The Office of the Prosecutor (“Prosecution”) herewith files in the case record the pre-inspection report regarding the disclosure to the Defence team of Laurent Gbagbo, on 12 March 2014, of six items pursuant to Rule 77 of the Rules of Procedure and Evidence.
2. The documents disclosed are P-414’s statement and its annexes, which were annexed to the *“Prosecution’s request pursuant to Regulation 35 for an extension of time to add one statement to its Amended List of Evidence for the purposes of the confirmation of charges and, if granted, to be permitted to apply redactions to this item of evidence pursuant to Rule 81(2)”* dated 26 February 2014.¹
3. These documents were disclosed with *proprio motu* redactions to their metadata. Five of these documents also contained redactions to their content. The redactions were applied pursuant to paragraph 51 of decision ICC-02/11-01/11-30, and in a format that complies with the e-Court protocol approved by the Pre-Trial Chamber. The redactions applied to the documents are in relation to names of OTP staff.
