1. The Office of the Prosecutor ("Prosecution") notifies Pre-Trial Chamber I ("Chamber") of the disclosure to the Defence team of Laurent Gbagbo, on 27 February 2014, of four items pursuant to Rule 77 of the Rules of Procedure and Evidence.¹
2. The disclosure package contains two witness statements² and two annexes to one of the statements: a press article and an organisation diagram.
3. All four documents contain *proprio motu* redactions to their image and metadata, applied in accordance with paragraph 51 of the Chamber's decision of 24 January 2012.³ The redactions applied to the documents are in relation to the names, signatures and initials of OTP investigators.
