1. The Office of the Prosecutor ("Prosecution") herewith informs the Chamber of the disclosure, on 30 August 2013, to the Defence team of Laurent Gbagbo, of 46 items pursuant to Rule 77 of the Rules of Procedure and Evidence.
2. Ten documents contain *proprio motu* redactions applied to their metadata; two of these documents also contain redactions to their content, relating to the names of OTP staff, to the identity of OTP sources and to identifying information of persons at risk on account of the Court's activities (innocent third parties). The redactions were applied in accordance with paragraph 51 of the Chamber's decision of 24 January 2012¹ and in a format that complies with the e-Court protocol approved by the Chamber.
