1. The Office of the Prosecutor ("Prosecution") herewith files in the case record the pre-inspection report regarding the disclosure to the Defence team of Laurent Gbagbo, on 15 January 2013, of nine items pursuant to Rule 77 of the Rules of Procedure and Evidence.¹
2. Three of the documents have two ERNs: 1) CIV-OTP-0024-0906 and CIV-OTP-0024-0906-0001; 2) CIV-OTP-0035-1977 and CIV-OTP-0035-1977-0001 and 3) CIV-OTP-0035-2050 and CIV-OTP-0035-2050-0001. The ERNs without the '-0001' extension are the original documents which were encrypted and the ERNs with the '-0001' extension are the decrypted documents in a readable format.
3. Three of the documents in this package were disclosed with *proprio motu* redactions to their metadata. One of these documents also contains redactions to its image. The redactions were applied pursuant to paragraph 51 of decision ICC-02/11-01/11-30, and in a format that complies with the e-Court protocol approved by the Pre-Trial Chamber. The redactions applied to the documents are in relation to names of OTP staff and to the identity of certain OTP sources.
