1. The Office of the Prosecutor (“Prosecution”) herewith files in the case record the pre-inspection report regarding the disclosure to the Defence team of Laurent Gbagbo, on 19 November 2012, of 114 items pursuant to Rule 77 of the Rules of Procedure and Evidence.
2. Sixty-eight documents contained in this package were collected at the Presidential Residence (“the Residence”).
3. The Prosecution also informed the Defence that seven of the disclosed items were a hand-over of material seized by the national authorities of Ivory Coast from CIV-OTP-P-0069. The “Transaction data” metadata field for these seven documents has been made available to the Defence.
4. Documents, including screenings and a number of Annexes, related to witnesses CIV-OTP-P-0164, CIV-OTP-P-0172, CIV-OTP-P-0184 and CIV-OTP-P-0185 were also contained in the said disclosure package.
5. Some of the documents disclosed to the Defence were provided with *proprio motu* redactions applied in accordance with paragraph 51 of the Chamber’s decision of 24 January 2012¹. The redactions applied to the documents are in relation to the identity of OTP staff, certain OTP sources and OTP leads, to dates of witness interviews, and to names and contact details of innocent third parties.
