1. The Office of the Prosecutor ("Prosecution") herewith files on the case record the pre-inspection report regarding the provision to the Defence team of Laurent Gbagbo on 8 June 2012 of 25 documents pursuant to Rule 77 of the Rules of Procedure and Evidence.
2. These 25 documents were disclosed to the Defence in annexes 1 to 23 of ICC-02/11-01/11-137-Conf on 4 June 2012.
3. Five of the documents disclosed to the Defence contain *proprio motu* redactions to their metadata, pursuant to paragraph 51 of decision ICC-02/11-01/11-30. The redactions to the metadata are related to the identity of OTP staff and the identity of OTP sources.¹
