The Office of the Prosecutor ("Prosecution") herewith notifies Pre-Trial Chamber I ("Chamber") of its disclosure, on 5 April 2012, to the Defence team of Laurent Gbagbo, of 18 incriminating documents.¹

Pursuant to Pre-Trial Chamber I's First decision on the Prosecutor's requests for redactions and other protective measures of 27 March 2012², the Prosecution disclosed the anonymous summaries of the statements of witnesses P-0054³ and P-0108⁴.

In compliance with Pre-Trial Chamber I's Decision on the "Prosecution's urgent request pursuant to Regulation 35 for variation of time limit to submit a request for redactions and Notice of information regarding the coming disclosure"⁵, the Prosecution provided the Defence with the redacted version of the 7 annexes to the statement of witness P-0011⁶, the redacted version of 1 document received from national judicial authorities,⁷ 4 videos⁸ and the transcripts of those videos⁹.
