Other

1. Pursuant to Trial Chamber I's decision of 13 February 2015,¹ the Office of the Prosecutor ("Prosecution") disclosed to the Defence of Charles Blé Goudé, 114 items of incriminating evidence, 10 items of potentially exculpatory evidence and 47 items pursuant to rule 77 of the Rules of Procedure and Evidence ("Rules"). The redactions applied to these disclosures are in accordance with the protocol adopted in the *Gbagbo* case.²
2. The Prosecution also provided the Defence with the re-issue of one metadata field (the "Main date") for four documents previously disclosed.³
3. The disclosed material was provided in a format that complies with the e-Court protocol as approved at the Pre-Trial stage.

4. Annexes A,⁴ B⁵ and C⁶ appended to this communication contain the disclosure notes provided to the Defence. The Prosecution requests that these annexes be received as "Confidential" since they relate to *inter partes* disclosure.
