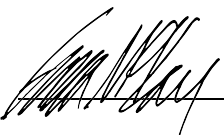

CONSIDERING that the applications of these five victim applicants were previously assessed by the Registry as falling outside the scope of case *The Prosecutor against Mr Laurent Gbagbo* and were thus not transmitted to Pre-Trial Chamber I in that case;
