1. The Office of the Prosecutor provides notice of the disclosure to the Defence teams of Laurent GBAGBO and Charles BLÉ GOUDÉ of ninety incriminating items¹ and one item pursuant to rule 77 of the Rules of Procedure and Evidence,² on 26 May 2015.
2. The incriminating material disclosed relates primarily to the identification and three autopsies of victims of the 3 March 2011 incident. A limited number of redactions were applied to the content of 49 of these documents, in accordance with the Redaction Protocol.³ The document disclosed pursuant to rule 77 of the Rules was provided with redactions to the content and metadata in accordance with the Redaction Protocol as well.
3. The disclosed material was provided in a format that complies with the eCourt protocol as approved in the case.⁴
