NOTING Trial Chamber VI’s (the “Chamber”) Decision on Victims’ Participation in Trial Proceedings notified on 6 February 2015 (the “First Victim Participation Decision”);¹

NOTING the Chamber’s oral ruling issued on 22 April 2015 during a status conference, ordering deadlines to be recalculated on the basis of a 7 July 2015 commencement date for trial;²

NOTING the Chamber’s Second Decision on Victims’ Participation in Trial Proceedings notified on 16 June 2015 (the “Second Victim Participation Decision”);³

NOTING article 68 (1) and (3) of the Rome Statute, rules 89(1) and 91(1) of the Rules of Procedure and Evidence and regulations 23 *bis* and 86(8) of the Regulations of the Court;

CONSIDERING that the annexes to the present document are notified with the status “Confidential *Ex Parte*, available only to the Registry” in accordance with the instructions provided by the Chamber at paragraph 24(i) of the First Victim Participation Decision;

CONSIDERING that the Chamber in paragraph 24(i) of the First Victim Participation Decision ordered the Registry to transmit all complete applications in its possession to the Chamber, on a rolling basis;

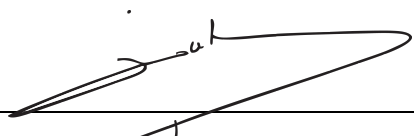
