Other

1. The Office of the Prosecutor (“Prosecution”) provides notice of the disclosure of the following packages to the Defence teams of Laurent GBAGBO and Charles BLÉ GOUDÉ on 26 June 2015:
 - a. Rule 77 package 14, containing the re-disclosure of 129 items with fewer redactions under rule 77 of the Rules of Procedure and Evidence.¹ For 37 of these items, some redactions to metadata and/or content remain in accordance with the Redaction Protocol;²
 - b. PEXO package 3, containing the re-disclosure of three potentially exonerating items with all redactions lifted;³
 - c. INCRIM package 16, containing 125 incriminating items.⁴ Forty-four of these documents were provided with redactions to their image or audio and/or metadata in accordance with the Redaction Protocol; and
 - d. Rule 77 package 15, containing 37 items pursuant to rule 77.⁵ Three of these documents were provided with redactions to their image in accordance with the Redaction Protocol.
2. In INCRIM package 16, the Prosecution has provided the audio recordings and interview notes⁶ of the interviews of Witnesses P-0435 and P-0500 since the transcripts are not yet complete.⁷
3. The disclosed material was provided in a format that complies with the eCourt protocol as approved in the case.⁸
