I. Introduction

1. The Office of the Prosecutor (“Prosecution”) herewith submits the report for evidence disclosed to the Defence team of Mr Jean-Pierre Bemba Gombo on 16 July 2015 pursuant to rule 77 of the Rules of Procedure and Evidence.¹ This communication is submitted in accordance with the operative disclosure regime, the Decision on the Evidence Disclosure System and Setting a Timetable for Disclosure between the Parties.²
