I. Introduction

1. The Office of the Prosecutor (“Prosecution”) herewith submits the report for evidence disclosed to the Defence team of Mr Jean-Pierre Bemba Gombo on 31 July 2015 pursuant to rule 77 of the Rules of Procedure and Evidence.¹ This communication is submitted in accordance with the operative disclosure regime, the Decision on the Evidence Disclosure System and Setting a Timetable for Disclosure between the Parties.²

2. In compliance with Trial Chamber III’s decision,³ the Prosecution disclosed additional rule 77 materials generated during contacts with Defence witnesses. Moreover, the Prosecution disclosed new versions of previously disclosed documents, in which redactions have been lifted.⁴

II. Request for Confidentiality

3. The Prosecution requests that Annex A appended to this communication be received by the Chamber as “Confidential”, as it relates to confidential evidence disclosed *inter partes*.
