4. On 27 July 2015, Mr Rodoma signed the undertaking required under article 22(3) of the Code.

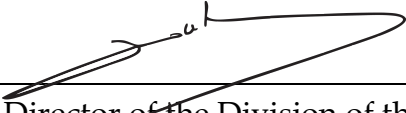
