NOTING articles 43 and 67(1)(d) of the Rome Statute, rules 21 and 22(1) of the Rules of Procedure and Evidence, regulations 23*bis* and 67 of the Regulations of the Court, regulation 123(1) of the Regulations of the Registry, and articles 5 and 22(3) of the *Code of Professional Conduct for counsel*¹ (the “Code”);

HEREBY NOTIFIES Trial Chamber VII (the “Chamber”) of the following:

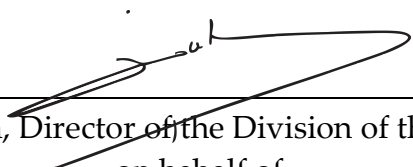
