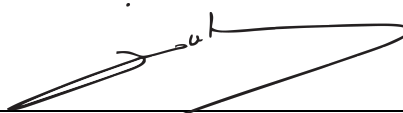
NOTING rule 13(1) of the Rules of Procedure and Evidence and regulation 23 *bis* (2) of the Regulations of the Court;
