1. Pursuant to Trial Chamber VII's order setting a trial date,¹ the Office of the Prosecutor ("Prosecution") submitted on 30 June 2015 its (i) list of witnesses; and (ii) list of evidence ("LoE") on which it intends to rely at trial.² Further to the Chamber's authorisation,³ the Prosecution hereby files an updated version of its LoE, adding 12 items of evidence.⁴

2. Confidential Annex A contains the Prosecution's third updated LoE.⁵ The LoE now contains 2,288 exhibits on which the Prosecution intends to rely at trial.
