1. The Office of the Prosecutor provides notice of the disclosure to the Defence teams of Laurent GBAGBO and Charles BLÉ GOUDÉ of 20 items pursuant to rule 77 of the Rules of Procedure and Evidence,¹ on 9 September 2015.
2. Thirteen of these items are applications for participation of dual status individuals, previously disclosed to both Defence teams. They are now re-disclosed, following the Chamber's decision of 2 September 2015,² with pseudonyms provided for each individual intermediary and with the redaction label "LRV" for intermediaries of Legal Representatives of the Victims.
3. The remaining seven items are disclosed without redaction, and in compliance with the Prosecution's ongoing obligation under rule 77 to disclose documents which are material to the preparation of the Defence.³
4. The disclosed material was provided in a format that complies with the eCourt protocol as approved in the case.⁴
