I. Notification

1. The Office of the Prosecutor ("Prosecution") submits this Communication Report regarding incriminating and rule 77 materials disclosed to the Defence teams of Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu, and Narcisse Arido on 21 September 2015.

II. Confidentiality

2. The Prosecution requests that Annexes A and B appended to this Report be received as "Confidential", as they relate to evidence disclosed *inter partes* that should not be released to the public.

III. Disclosure of evidence

3. *Confidential* Annex A to this filing lists the disclosed incriminating evidence, consisting of five transcripts which are being re-disclosed as a result of corrections.

4. *Confidential* Annex B to this filing lists the disclosed rule 77 material, which includes 15 documents containing: (i) three documents related to the rule 68 certification of P-0243, P-0020, and P-0242's prior recorded testimony; (ii) eight witness expenses related to P-0243, P-0020, and P-0242; (iii) the *curriculum vitae* of P-0433; and (iv) three investigators reports concerning P-0263 and P-0272.¹
