NOTING the "Notification of the appointment of Mr Mohamed Aouini as Duty Counsel for Mr Ahmad Al Faqi Al Mahdi" submitted by the Registry on 29 September 2015;¹

NOTING article 67(1)(d) of the Rome Statute, rules 21 and 22 of the Rules of Procedure and Evidence, regulations 23*bis* and 67 of the Regulations of the Court, and regulation 123 of the Regulations of the Registry;

RESPECTFULLY INFORMS the Single Judge of:

1. The choice of Counsel made freely by Ahmad Al Faqi Al Mahdi in favour of Mr Mohamed Aouini ("Mr Aouini");²
2. The acceptance of mandate by Mr Aouini as required in Article 11 of the Code of Professional Conduct for counsel (the "Code") (ICC-ASP/4/Res.1).³ On 24 August 2015, Mr Aouini executed solemn undertakings required by articles 5 and 22(3) of the Code,⁴ which remain valid for the purpose of these proceedings;
3. The letter from the Registry officially formalizing the appointment of Counsel.⁵

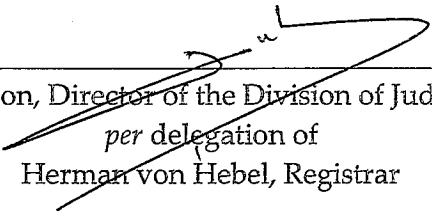
