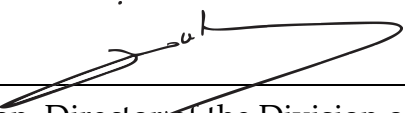
HEREBY INFORMS Trial Chamber VII (the “Chamber”) as follows:
