I. Notification

1. The Office of the Prosecutor (“Prosecution”) submits this Communication Report regarding incriminating evidence and rule 77 material disclosed to the Defence teams of Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu, and Narcisse Arido on 23 October 2015.

II. Confidentiality

2. The Prosecution requests that Annex A and B appended to this Report be received as “Confidential”, as they relate to material disclosed *inter partes* that should not be released to the public.

III. Disclosure of evidence

3. *Confidential* Annex A to this filing lists the disclosed incriminating evidence, which comprises twenty documents, namely: (i) sixteen English translations of previously disclosed audios related to P-0198 and P-0201; and (ii) four transcripts/translations which are being re-disclosed as a result of corrections.

4. *Confidential* Annex B to this filing lists the disclosed rule 77 material, which comprises fourteen documents, namely: (i) three witness expenses related to P-0243, P-0270, and P-0272; (ii) three witness expenses charts for P-0020, P-0242 and P-0243;¹
