Introduction

1. Pursuant to the Trial Chamber's Decision of 21 October 2015,¹ the Prosecution submits (i) an amended version of its List of Witnesses,² in confidential Annex A, accompanied by (ii) an amended summary of the main facts outlining each witness's expected testimony,³ in confidential Annex B; (iii) an amended version of its List of Evidence,⁴ with amendments highlighted, in confidential Annex C; and (iv) a clean version of its amended List of Evidence, in confidential Annex D.

Confidentiality

2. The Prosecution submits Annexes A, B, C and D as confidential since they contain the names and identifying information of witnesses and relate to evidentiary material that is currently to be treated as confidential.

Procedural History

3. On 30 June 2015, the Prosecution submitted its List of Witnesses and List of Evidence.⁵ The List of Witnesses was provided in confidential Annex A to the submission, a consolidated document containing the witness summaries in confidential Annex B, and the List of Evidence in confidential Annex C.
4. On 24 July 2015, the Prosecution filed a notice indicating its withdrawal of Witness P-0439 from its List of Witnesses.⁶
5. On 27 July 2015, the Prosecution submitted corrected versions of its List of Witnesses⁷ and its consolidated document containing the witness summaries.⁸

6. On 18 August 2015, the Chamber issued its first decision on variation of the time limit for the Prosecution to disclose certain documents.⁹ This decision related to the Prosecution's requests of 30 June 2015,¹⁰ 2 July 2015¹¹ and 27 July 2015.¹²
7. In its Second Decision of 21 October 2015, the Chamber granted the Prosecution's requests of 2 September 2015,¹³ 7 September 2015¹⁴ and 22 September 2015¹⁵ for variation of the time limit for disclosure of certain documents and to add incriminatory material to its List of Evidence.¹⁶ It also granted the Prosecution's request of 15 September 2015¹⁷ to add Witness P-0606 to its List of Witnesses. The Chamber ordered the Prosecution to file an amended version of its List of Witnesses, to include certain information in its document entitled "Witness Summaries covering Main Facts", and to file an amended version of its List of Evidence.¹⁸

Submissions

8. Pursuant to the Chamber's Second Decision, the Prosecution submits its amended List of Witnesses and accompanying Summary of Main Facts to include Witness P-0606. Consistent with its Notice of Withdrawal, the Prosecution has removed P-0439 from both documents.
