The Registrar of the International Criminal Court (“the Court”),

NOTING article 68 of the Rome Statute, rules 21 and 74 of the Rules of Procedure and Evidence (the “Rules”), regulations 23*bis*, 67 and 69 of the Regulations of the Court, regulation 123(1) of the Regulations of the Registry, and articles 5, 8 and 22(3) of the Code of Professional Conduct for counsel¹ (the “Code”);

HEREBY INFORMS Trial Chamber VII as follows:

1. On 28 October 2015, the Registrar appointed Mr B Jean-Marie Chaussonniere as Legal Adviser to witness P-0214 pursuant to rule 74 of the Rules;²
2. On the same day, Mr Chaussonniere was provided with electronic access to the statements and transcripts of interviews of witness P-0214 *via* a secure channel in order to maintain at all times due respect for confidentiality;³
3. Mr Chaussonniere discharged the solemn undertakings required by articles 5 and 22(3) of the Code on 2 October 2015.⁴
