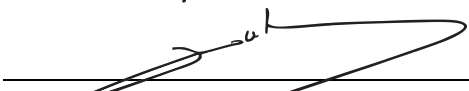
CONSIDERING that the Submission was addressed to Trial Chamber III ("the Chamber") for registration in the case ICC-01/05-01/08 ("the Main Case");
