I. Notification

1. The Office of the Prosecutor (“Prosecution”) submits this Communication Report regarding incriminating evidence and rule 77 material disclosed to the Defence teams of Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu, and Narcisse Arido on 20 November 2015.

II. Confidentiality

2. The Prosecution requests that Annexes A and B appended to this Report be received as “Confidential”, as they relate to material disclosed *inter partes* that should not be released to the public.

III. Disclosure of evidence

3. *Confidential* Annex A to this filing lists the disclosed incriminating evidence, which comprises a total of 31 documents: (i) 29 documents are re-disclosed as a result of the lifting of redactions in compliance with the timelines prescribed in the 22 May 2015 Redaction Protocol;¹ and (ii) the transcript and translation of audio CAR-OTP-0074-0306 are re-disclosed due to corrections.²

4. *Confidential* Annex B to this filing lists the disclosed rule 77 material, which comprises a total of 63 documents: (i) 61 documents are re-disclosed as a result of the lifting of redactions in compliance with the timelines prescribed in the 22 May 2015
