I. Introduction

1. The Defence for Charles Blé Goudé (the “Defence”) herewith submits its notification of material intended to be used in the course of the Blé Goudé Defence opening statements ¹ disclosed to Trial Chamber I (the “Chamber”), the parties, and the Legal Representative of Victims (the “LRV”).
2. The material is notified pursuant to, and in accordance with the Chamber’s Directions on the conduct of proceedings,² and the Presiding Judge’s decision to grant an extension of time until 25 January 2016 to disclose any material to be used during the course of the opening statements.

III. Submissions

3. The Defence intends to use during its opening statements the following materials: 19 videos and (ii) 7 documents. One of the videos has been disclosed by the Prosecution, and is currently in eCourt. The reference number is CIV-OTP-0061-0549. The Defence will disclose the rest of the material onto eCourt by the close of business on 25 January 2016.
