**Judge Bertram Schmitt**, acting as Single Judge on behalf of Trial Chamber VII ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu and Narcisse Arido*, having regard to Regulations 23 *bis* and 35 of the Regulations of the Court, issues the following 'Decision on Kilolo Defence Request to Amend its List of Evidence'.

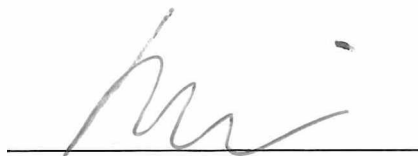
1. On 26 January 2016, the defence team for Mr Kilolo ('Kilolo Defence') informed the Chamber that one item was inadvertently not disclosed or included on its list of evidence.<sup>1</sup> The list of evidence was due on 21 January 2016. The Kilolo Defence requests authorisation to file an amended list of evidence with this additional item, which is an open source report disclosed on 26 January 2016.
2. This request is made soon after the deadline and concerns a single open source item. The Single Judge does not find any prejudice in adding this item.

**FOR THE FOREGOING REASONS, THE SINGLE JUDGE HEREBY**

**GRANTS** the Kilolo Defence request to submit an amended list of evidence; and

**ORDERS** the Registry to reclassify ICC-01/05-01/13-1577-Conf as 'public'.
