I. NOTIFICATION

1. The Defence for Narcisse Arido ("The Defence") hereby submits a notification of items disclosed to the Defence teams of Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu, and the Prosecution on 21 January 2016.
