I. Notification

1. The Office of the Prosecutor (“Prosecution”) submits this Communication Report regarding rule 77 materials disclosed to the Defence teams of Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu, and Narcisse Arido on 4 February 2016. Some of these materials are being disclosed with redactions in compliance with the 22 May 2015 Protocol establishing a redaction regime¹ (“Redaction Protocol”).

II. Confidentiality

2. The Prosecution requests that Annex A appended to this Report be received as “Confidential”, as it relates to material disclosed *inter partes* that should not be released to the public.

III. Disclosure of evidence

3. *Confidential* Annex A to this filing lists the disclosed rule 77 materials, which comprises a total of 86 documents: (i) 17 emails and attachments between OTP and Witness P-0267; (ii) 19 emails and attachments seized from Arido's email account; (iii) one summary of Witness D-0008 from the Main Case;² and (iv) 49 documents received from State authorities in response to Prosecution's Requests for assistance. The documents are disclosed subsequent to the Defence witness lists filed on 21 January 2016.³
