I. Introduction

1. The present filing is submitted pursuant to decision ICC-01/05-01/13-1651 ordering the Registry, among others, to apply redactions to certain documents (“the Decision”)¹.

II. Procedural History

2. In the Decision, Trial Chamber VII (“the Chamber”) ordered the Registry to apply all required redactions to documents ICC-01/05-01/13-845-Conf-Exp-AnxD; ICC-01/05-01/13-845-Conf-AnxA1-Red; and ICC-01/05-01/13-982-Conf-Anx4-Red. These documents were submitted by the Independent Counsel.
3. On 26 February 2016, and as directed by the Chamber, the Bemba Defence² and the Kilolo Defence³ respectively submitted their proposed redactions to ICC-01/05-01/13-845-Conf-Exp-AnxD.

III. Classification

4. Pursuant to regulation 23*bis* of the Regulations of the Court, the annex to this submission is classified as confidential because it relates to the information that is only available to the parties.
