1. On 29 April 2016, the Trial Chamber issued its 'Decision on Requests to Exclude Dutch Intercepts and Call Data Records',¹ and its 'Decision on Requests to Exclude Western Union Documents and other Evidence Pursuant to Article 69(7)' (the Decisions).²

2. The deadline for filing a request for leave to appeal the Decisions is 9 May 2016.

3. In light of Mr. Bemba's right to an expeditious trial, and the advanced stage of the proceedings, the Defence has not sought interlocutory appellate relief.

4. This should not, however, be construed as a waiver of Mr. Bemba's right to raise issues arising from the Decisions in any future appellate proceedings.
