1. The Prosecution requests the Single Judge, under Rule 81(2) of the Rules of Procedure and Evidence, to approve the proposed temporary redactions to the Arrest Warrants¹ for BEMBA, KILOLO, MANGENDA, and ARIDO.
2. The proposed temporary redactions are necessary to avoid compromising the arrest of BABALA. The Prosecution intends to request the cooperating states of The Netherlands, Belgium, and France to arrest KILOLO, MANGENDA, and ARIDO on [REDACTED]. BEMBA will be informed of the arrest warrant by the Registry around the same time. BABALA's arrest will be executed [REDACTED]. Given the importance of the timing of BABALA's arrest to the overall operation, [REDACTED]. However, the final decision ultimately lies with them.
3. Presently, the sequence of arrests means that there will be a 24 to 48 hour window between the first wave of arrests and BABALA's. This creates a potentially serious obstacle to completing the DRC leg of the operation successfully: once the suspects are arrested and informed of the arrest warrant there, is a high risk that BABALA will be contacted and will take steps to flee and/or to destroy evidence, rendering the search and seizure operation futile. The risk of BABALA absconding can be mitigated by [REDACTED]. However, there is no way of preventing him from destroying evidence in his possession.
4. In light of this, the Prosecution requests that the Single Judge authorize under Rule 81(2) limited temporary redactions to the warrant of arrest to be served on the suspects upon arrest warrant, comprising BABALA's name and other identifying information. The Prosecution believes \ these redactions, coupled with restricting the suspects' abilities to communicate with third parties, will minimize the risks to the arrest operation and the ensuing investigative steps to

be taken in the DRC. Once BABALA is arrested the need for the redactions will no longer be present and the redactions should be lifted.

5. The relief sought is approval of the proposed redactions contained in the annexed document.
