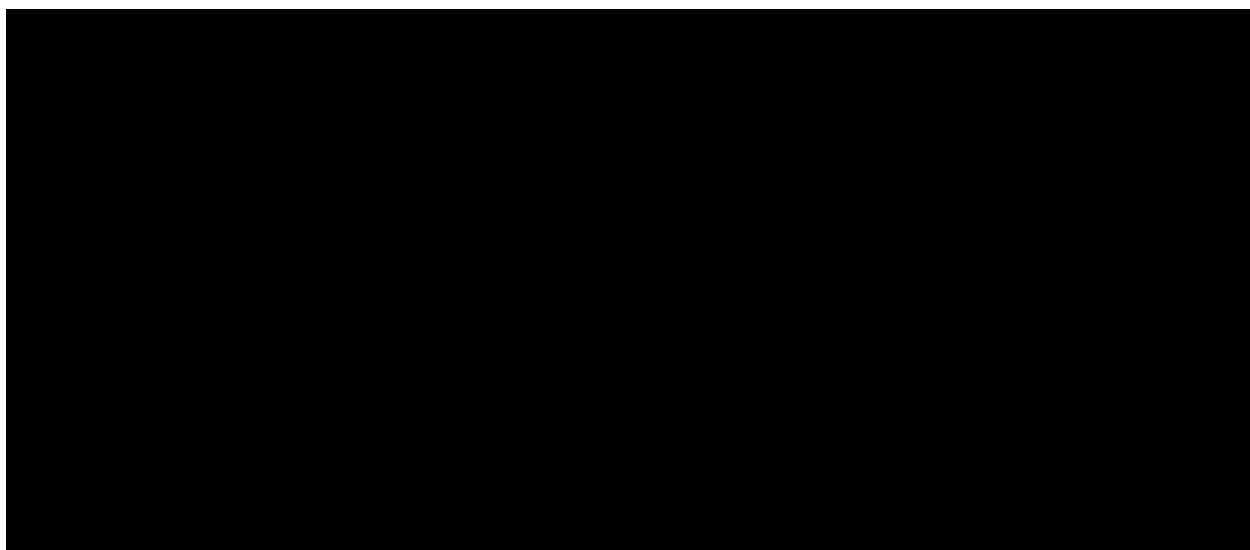
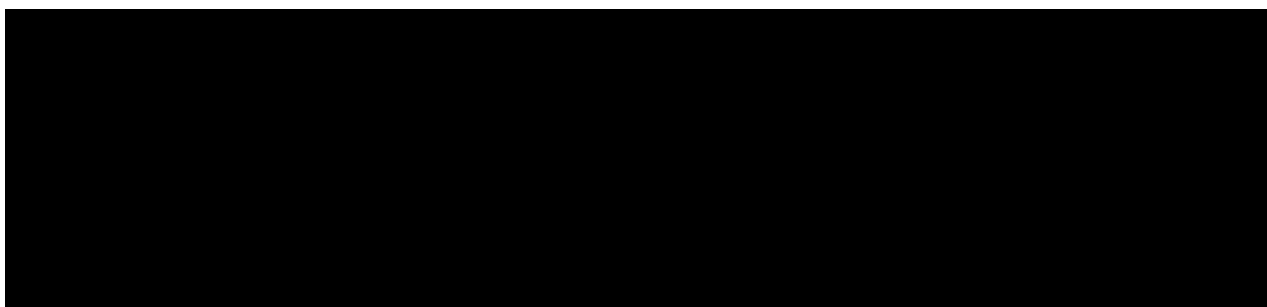

Pursuant to Regulation 23*bis*(3) of the Regulations of the Court, the Defence for Jean-Pierre Bemba Gombo ("the Suspect") hereby requests that the Single Judge order the reclassification of ICC-01/05-01/13-631-Conf-Anx5 so that access to this document is granted him.

1. On 14 August 2014, Me. Ghislain Mabanga submitted a request to withdraw from the representation of the co-Suspect – Aime KILOLO.¹



4. One of the documents produced by Me. Mabanga in support of his request to withdraw was not communicated to the Suspect since it was liable "*d'avantager l'une ou l'autre partie*".² The Suspect believes that if this document is, indeed, capable of corroborating his defence, it should be reclassified so that he has access to it.
