1. In accordance with Trial Chamber IX's "Decision Setting the Commencement Date of the Trial"¹ and the "Decision on the Prosecution request for variation of the time limit to provide its provisional list of witnesses and summaries of their anticipated testimony"², the Prosecution hereby submits its provisional list of witnesses as of 9 August 2016 (Annex A) and the provisional summaries of anticipated testimony of Prosecution Witnesses P-0048, P-0085, P-0105, P-0138, P-0144, P-0187, P-0202, P-0224, P-0245, P-0258, P-0410, P-0414 (Annex B).
2. There are no provisional summaries of the evidence of Witnesses P-0406 and P-0422. The interview of P-0406 was sound recorded and the Prosecution has not yet received the transcripts of recording. As soon as these are received they will be reviewed and disclosed to the Defence. The expert report to be written by P-0422 is expected at the end of August 2016. It will be dealt with in the same way. As a result, the Prosecution will submit the summaries for these two witnesses with its final list of witnesses and summaries on 6 September 2016.
