Judge Bertram Schmitt, acting as Single Judge on behalf of Trial Chamber VII ('Single Judge' and 'Chamber', respectively) of the International Criminal Court, in the case of *The Prosecutor v. Jean-Pierre Bemba Gombo, Aimé Kilolo Musamba, Jean-Jacques Mangenda Kabongo, Fidèle Babala Wandu and Narcisse Arido*, having regard to Article 67(1)(d) of the Rome Statute and Regulations 23 *bis* and 78 of the Regulations of the Court, issues the following 'Decision on Kilolo Defence Counsel's Request to Withdraw'.

1. On 18 November 2016, Mr Paul Djunga, the lead counsel for Mr Kilolo ('Counsel'), requested leave to withdraw on this case on grounds that Mr Kilolo wished to appoint another lead counsel ('Request').¹
2. The Single Judge notes Mr Kilolo's right to legal assistance of his choosing² and will permit Counsel to withdraw. However, the late stage of the proceedings before this Chamber must be emphasised. The judgment has already been rendered³ and all sentencing submissions are due in the next month.⁴
3. Accordingly, Counsel may only withdraw subject to three conditions. First, Counsel must ensure that Mr Kilolo fully understands and accepts the fact that he cannot seek postponement of any sentencing deadlines⁵ on grounds related to new counsel joining the case at this late stage. Second, and noting that Mr Kilolo has lodged a notice of appeal against the judgment before the Appeals Chamber,⁶ Counsel must also seek and receive permission to withdraw from the Appeals Chamber before the withdrawal can become effective. Third, Counsel must continue to represent Mr Kilolo until new counsel is appointed.
