Introduction

1. The Office of the Prosecutor ("Prosecution") provides notice of the disclosure of evidence pursuant to articles 64(3)(c) and 67(1)(a),(b) of the Rome Statute, and rules 76(3) and 77 of the Rules of Procedure and Evidence.

Submission

2. On 21 November 2016, the Prosecution disclosed to the Defence one package of evidence: Pre-trial INCR package 33 containing 20 items/397 pages. They are Acholi and English versions of the English only transcripts previously disclosed or Acholi translations of the Prosecution witnesses' statements.

3. The Prosecution recognises its ongoing obligation of disclosure under article 67(2) and rule 77 which it will continue to fulfil throughout the trial
