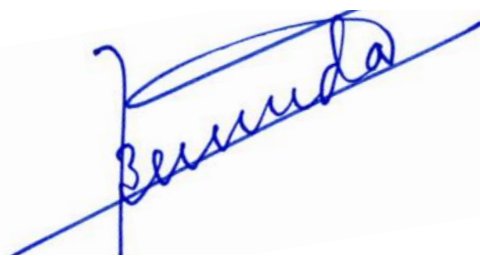

1. The Prosecution submits an updated version of its List of Evidence¹ that incorporates all new incriminating material disclosed since June 2016.² The additions consist of agreed maps, translations of reports and documents already on the List of Evidence, still images (photographs) derived from videos already on the List of Evidence, slow motion videos extracted from videos already on the List of Evidence, rule 68(2)(b) declarations related to several Prosecution witnesses and transcripts of documents and audio-visual material already on the List of Evidence.
2. Confidential Annex A is a clean copy of the amended List of Evidence. Confidential Annex B is a marked-up version of the amended List of Evidence, with all additions designated by yellow highlighting. Confidential Annex C is a list of all additions to the List of Evidence.
