I - Introduction

3. The Registry respectfully informs the Chamber that the current composition of the defence team for Mr Mangenda is composed as follows:

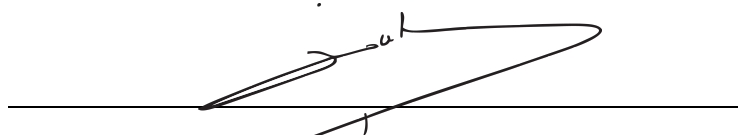
- Mr Christopher Gosnell – Counsel;
