The Appeals Chamber of the International Criminal Court,

In the appeal of Mr Laurent Gbagbo against the oral decision of Trial Chamber I of 29 November 2016 (ICC-02/11-01/15-T-107-Conf-Eng, pp. 1-2),

Having before it Mr Gbagbo's "Document à l'appui de l'appel interjeté à l'encontre de la décision de la Chambre, rendue oralement le 29 Novembre 2016, refusant à la Défense la levée d'une expurgation apposée par l'Accusation au point 24 de la demande de participation de P-0350" of 13 February 2017 (ICC-02/11-01/15-809-Conf (OA9)), in which he refers, in footnotes 1, 2, and 11, to e-mails of 25, 27 and 28 November 2016, respectively, which currently are not part of the record of the case,

Considering that it is appropriate to require the respective authors of these e-mails to file these e-mails into the record,

Issues the following

ORDER

1. Mr Gbagbo shall file the e-mail of 25 November 2016 referred to in footnote 1 by 22 February 2017.
2. The Prosecutor shall file the e-mail of 27 November 2016 referred to in footnote 2 by 22 February 2017.
3. The Common Legal Representative of the victims shall file the e-mail of 28 November 2016 referred to in footnote 11 by 22 February 2017.
4. The above-mentioned e-mails shall be filed confidentially.
