Revised Witness Summary of D-0172

I. PROCEDURAL BACKGROUND

1. On 30 January 2017, the Chamber instructed the Defence to provide by 26 April 2017 “the final version of its list of witnesses, together with accompanying estimates for length of examination and statements or summaries of anticipated testimony [...] as well as its final list of evidence”.²
2. On 31 March 2017, the Defence provided its *Further Provisional List of Defence Witnesses and Summaries*.³
3. On 26 April 2017, the Defence submitted its *Defence Final Lists of Witnesses and Evidence*.⁴
4. On 11 May 2017, the Chamber issued its *Further Decision*.

II. PROVISION OF REVISED SUMMARY

5. Further to the submission of Witness D-0172’s summary on 31 March 2017⁵ and having clarified the information provided earlier by the Witness, the Defence hereby submits an updated summary.
