NOTIFICATION

1. The Defence for Dominic Ongwen hereby notifies Trial Chamber IX, the Prosecution and Legal Representatives for Victims that the Defence it disclosed 4 items on 10 November 2017 and 3 items on 14 November to the Prosecution and eCourt.
