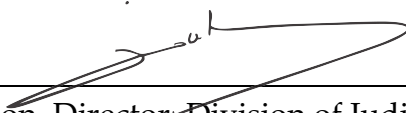

Transmission

1. Pursuant to paragraph 17 of Trial Chamber I's "Decision on the resumption of action applications" ("Decision") issued on 11 October 2017, the Registry hereby transmits, as an annex to this filing, an updated consolidated list of victims participating in the proceedings ("List").¹
2. The Registry notes that no new resumption of action applications have been transmitted by the Legal Representative of Victims to the Registry since the issuance of the Decision, and that the List reflects all 726 victims currently participating in the proceedings, including the six applicants authorised to resume the action of deceased participating victims by the Decision.²
3. Pursuant to the Decision, the Registry will in the future transmit the List in an updated version at least twice per calendar year until the conclusion of the proceedings before the Chamber.³
