1. The Prosecution submits an updated version of its List of Evidence¹ that incorporates all new incriminating material disclosed since 29 March 2017.² The additions consist of 193 video stills from videos already on the List of Evidence, 840 transcripts of videos, 19 translations of videos already on the List of Evidence, 7 updated *curriculum vitae* which were provided ahead of the witnesses' testimonies, 1 witness related expense record, 1 press article, 1 French version of an UNOCI report and 1 investigator's report.
2. Confidential Annex A is a clean copy of the amended List of Evidence. Confidential Annex B is a marked-up version of the amended List of Evidence, with all additions designated by yellow highlighting. Confidential Annex C is a list of only the additions to the List of Evidence.
