I. Introduction

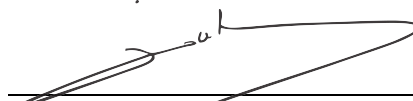
1. This report is submitted in implementation of the “Decision inviting the Republic of Uganda to provide submissions concerning its failure to arrest Omar Al-Bashir and surrender him to the Court” (“Decision”) issued by Pre-Trial Chamber II on 13 December 2017.¹ The authorities of Uganda were invited to provide their submissions by 22 January 2018.

II. Classification

2. Pursuant to regulation 23 *bis*(1) of the Regulations of the Court, the Annex to this submission is classified as confidential because it refers to individual staff members of the International Criminal Court.

III. Submissions
